## PRAY FOR BRAIN CONCERT ENGAGEMENT AGREEMENT

2. **PRODUCTION AND TECHNICAL RIDER:** As further consideration the parties agree to the Production and Technical Rider attached to this Agreement and incorporated herein by reference.

3. **CONSIDERATION:** The consideration to be paid by Purchaser to Pray For Brain shall be as follows:

a. **Guaranteed Fee:** \$ \_\_\_\_\_ ("Artist's Fee").

c. **Transportation:** See Attached Production and Technical Rider

d. **Lodging:** See Attached Production and Technical Rider

e. **Deposit:** A bank transfer by wire made out in the name of Pray For Brain in the amount of fifty percent (50%) of Pray For Brain's Fee to be paid as a deposit ("Deposit") in US dollars for Pray For Brain's performance shall be payable to Pray For Brain and received by Pray For Brain on the \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_. In the event Pray For Brain does not receive the Deposit by the date set forth herein, Pray For Brain may terminate the agreement by written notice to Purchaser.

f. **Balance of Pray For Brain's Fee:** The balance of fifty percent (50%) of Pray For Brain's Fee made payable to Pray For Brain shall be paid to Pray For Brain in cash no less than one (1) hour prior to the beginning of Pray For Brain's performance under this Agreement.

**g. Complimentary Tickets for Pray For Brain :** See Attached Production and Technical Rider.

**h. Backstage Passes for Pray For Brain :** See Attached Production and Technical Rider

**6. ENTIRE AGREEMENT:** This Agreement and the attached Performance and Technical Riders, which are incorporated into and made a part of this Agreement, constitute the entire agreement between the parties and supersedes all prior and contemporaneous agreements, understanding, negotiations and discussions, whether oral or written. This Agreement shall not be binding until it, has been signed by both parties.

**7. APPLICABLE LAW:** This Agreement has been entered into in the State of New Mexico and the validity, interpretation and legal effect of this Agreement shall be governed by the laws of the State of New Mexico applicable to contracts entered into and performed entirely within the State of New Mexico . With respect to the determination of any claim, dispute or disagreement, which may arise out of the interpretation, performance, or breach of this agreement , such claim shall be filed in \_\_\_\_\_ County, \_\_\_\_\_.
